**Eric Arnesen,** a professor of history at the University of Illinois at Chicago and past president of The Historical Society is currently writing a biography of A. Philip Randolph.

**Tanya Basok** is the Director of the Centre for Studies in Social Justice and Professor at the Department of Sociology and Anthropology, University of Windsor.
